

# ESA Program Eligibility Worksheet 2023-24

Use this worksheet to collect your household and income information. These details will help you check your eligibility for the Education Savings Account (ESA) program before you begin the application.

If you file income taxes, please have your *most recent* (2022) federal income tax return (1040 form) on hand.

#### The Student (please check all that apply)

Is a resident of Tennessee and is zoned to attend a Memphis-Shelby County district school, a Metro Nashville public school, a Hamilton County public school, OR a school that was in the Achievement School District (ASD) on May 24, 2019.	
Is entering Kindergarten or will be in 1st through 12th grade.	
Is enrolling in Tennessee schools for the first time OR was enrolled in and attended a Tennessee public school for the full 2022-23 school year OR used an ESA in the 2022-23 school year.	
Previously enrolled in and attended a Tennessee public school for the entire school year in 2019-2020, 2020-2021, or 2021-2022.	
Was eligible to enroll in a Tennessee public school for the first time in one of the following school years: 2019-2020, 2020-2021, or 2021-2022.	

Household income must also meet eligibility requirements.

#### Household Size and Income

**Does your family receive Temporary Assistance for Needy Families (TANF) benefits?** If yes, be prepared to provide a letter of eligibility TANF/Families First benefits with the application. You can get a copy of the letter from the Families First office or online at <a href="https://www.tn.gov/humanservices/for-families/families-first-tanf.html">www.tn.gov/humanservices/for-families/families-first-tanf.html</a>.

**Do you file federal income taxes?** The following questions should be answered using your *most recent (2022) federal income tax return (1040 form):* 

- 1. What was your total household size? (Every individual identified and/or claimed as dependent upon the taxpayer(s) most recent federal income tax return.)
- 2. What was your total income for that year? (Amount may be found on line 9 of the 2022 Form 1040)

	Utility bill (water, electric, gas, or internet)		
	Voter registration card issued within the past year		
	Homeowner or renter's insurance bill issued within the past three months		
	Non-expired Tennessee state ID or driver's license		
	Vehicle registration from within the past year		
	Affidavit from landlord or owner of your current residence (See sample online.)
